PICTURE ORGANIC CLOTHING/GLISSHOP Contest Rules

Article 1: Organizing company

1.1 GLISSHOP which Head Office is located at 67 rue des Varennes, 63170 AUBIERE, FRANCE, organises a contest with an obligation of purchase, from the 2nd of October to the 2nd of November 2020. This contest will be referred as 'the Game' or 'the Offer' in the rules below.

1.2 The Offer is named: "PICTURE ORGANIC CLOTHING/GLISSHOP contest". It is visible on promotional banners set on the website (<u>www.glisshop.co.uk</u>) and on social networks like Facebook, Instagram.

Article 2: Participation requirements

2.1 This Game is open to any physical person, customer at GLISSHOP, residing in a country covered by GLISSHOP delivery service and meeting the following condition.

Any customer making this purchase will be automatically qualified for the prize draw set by Salomon and GLISSHOP.

2.2 Any physical person who has not registered in the customer database of the organizing company and/or who has not met the conditions mentioned hereabove, any staff from the organizing company or partner companies, including family, and any person under 18 will be excluded from the Game.

2.3 People who have not provided their complete contact details and identity or who have provided inaccurate or false information will be disqualified. Same applies to the persons who refuse the collection, the registration and the use of their nominative information needed for the process of the competition.

2.4 The qualification to the Game implies that any participant fully understands and accepts the rules set out here. Failure to observe these rules will result in the cancellation of the participation to the Game. If a customer does not wish to be qualified or refuses one or more conditions set out here, the customer must notify the organizing company by mail. This will ensure his immediate disqualification upon request.

Article 3: Prizes

Article 4: Process to select participants to the prize draw

Article 5: Determining winners and awarding prizes.

5.1 Winner will be designated by a draw among every qualified participants. This draw will take place on November 5th, 2020.

5.2 The prize draw will determine a Winner.

5.3 The winner receives only one prize. (unique name and address).

5.4 The winner will be designated after the organizing company has checked that his participation was legitimate. The organizing company will contact the winner by email with the email address provided in the customer account or at the cashier if the purchase of the Atomic product was made in store. If the winner does not respond in the 8 days following the email, the organizing company will consider that the winner refuses the prize and the prize will remain the property of the organizing company.

5.5 By accepting his prize, the winner authorises the organizing company to use his first name, last name, city and region for any promotion and advertising on the organizing company's website and on any affiliate support or site. This use is not subject to any form of remuneration other than the prize won.

6.2 The prize cannot be exchanged with another item (or with the same item of another colour or size) or with actual money and no partial or full refund can be claimed.

6.3 The value given to the prize is generally the retail price including VAT that is applied at the time the rules are being set. It is given as an indication and may vary. The organizing company cannot be held responsible for any issue/accident that may occur when using the prize. Every brand or product name mentioned was registered by their respective owner.

Article 7: Limit of liability

7.1 The participation to the "PICTURE ORGANIC CLOTHING/GLISSHOP contest" implies the acknowledge of the specifications of the Internet and its limits, especially regarding technical performances, response time for checking or forwarding information, risk of disruption, and more generally risks involved with any connection and internet transmission, the lack of protection of specific data against their misappropriation and the risks of a potential virus infection. 4. The loss of any mail or email and more generally, the loss of any data;

5. Routing issues;

6. The correct functionning of a software;

7. The consequences of any virus, digital bug, flaw or technical failure;

8. Any damage occuring on a customer's computer;

9. Any failure of any kind, software or hardware, which prevented the order from being processed correctly;

10. Any malfunction of the prizes distributed for the contest, and any possible damage they may cause, direct or indirect.

7.2 It is acknowledged that the company GLISSHOP cannot be held responsible for any damage, direct or indirect, caused by a disruption or a malfunction of any kind or for any reason whatsoever, or for any direct damage that may result from a connection to the site developed for this contest. It is the responsibility of every customer to take every appropriate actions to protect his own data and / or software installed on his device from any violation.

7.3 The organizing company can cancel all or part of the "PICTURE ORGANIC CLOTHING/GLISSHOP contest" if it turns out that fraud has been committed in any form at any time. 7.5 The organizing company reserves the right to exclude from the contest any person with a fraudulent behaviour who may affect the smooth conduct of the Game.

Article 8: Rules

Article 9: Personal data
